

Council meeting highlights **DECEMBER** 11[™] 2024

Report from Program Managers

Erin Vieira provided an update on program operations since the last SWC meeting:

- The Shuswap Water Monitoring Group (committee of the SWC) held a biannual meeting in November to discuss 2024 water monitoring programs by all organizations
- The SWC Water Quality Grant Program is open for applications. The intake • window is December 1st 2024 – January 31st 2025. Prospective applicants can learn more and apply online at www.shuswapwater.ca.
- The Fraser Basin Council (program manager for the SWC) is expecting a • \$170,000 grant from Environment & Climate Change Canada (Canada Water Agency) to advance the next stage of the Wetland Strategy and other workplan items
- Educational campaigns and early-detection monitoring for invasive mussels in the Shuswap watershed wrapped up mid-late fall
- Staff relayed that a new occurrence of whirling disease (a parasite affecting salmon, trout and whitefish) has been detected in Kootenay Lake highlighting the need for everyone to follow best practices including cleandrain-dry for watercraft and water gear and stopping for watercraft inspection when travelling
- The Fraser Basin Council is applying for funding from the Provincial Watershed Security Fund on behalf of the SWC for 2025 and 2026
- Operational expenses for 2024-25 total \$144,547 against an operating budget of \$299,711.

Discussion with DFO staff re: invasive mussels

Mr. Joshua Lindner, Senior Regional Advisor for BC to the federal Minister of Fisheries and Oceans Canada, attended the meeting to participate in a roundtable discussion about Zebra & Quagga Mussels. There was a lengthy Q&A session with SWC members and Mr. Lindner.

Revised budget for 2024-25

Staff presented a revised budget for the Shuswap Watershed Council to reflect the \$170,000 grant from Environment & Climate Change Canada (Canada Water Agency).

New Terms of Reference and membership

The SWC approved a new Terms of Reference, including membership, to take effect April 1st, 2025. The membership will include representatives of local/regional government, First Nations, Provincial government agencies, the agriculture sector, community representatives, and a youth representative.
